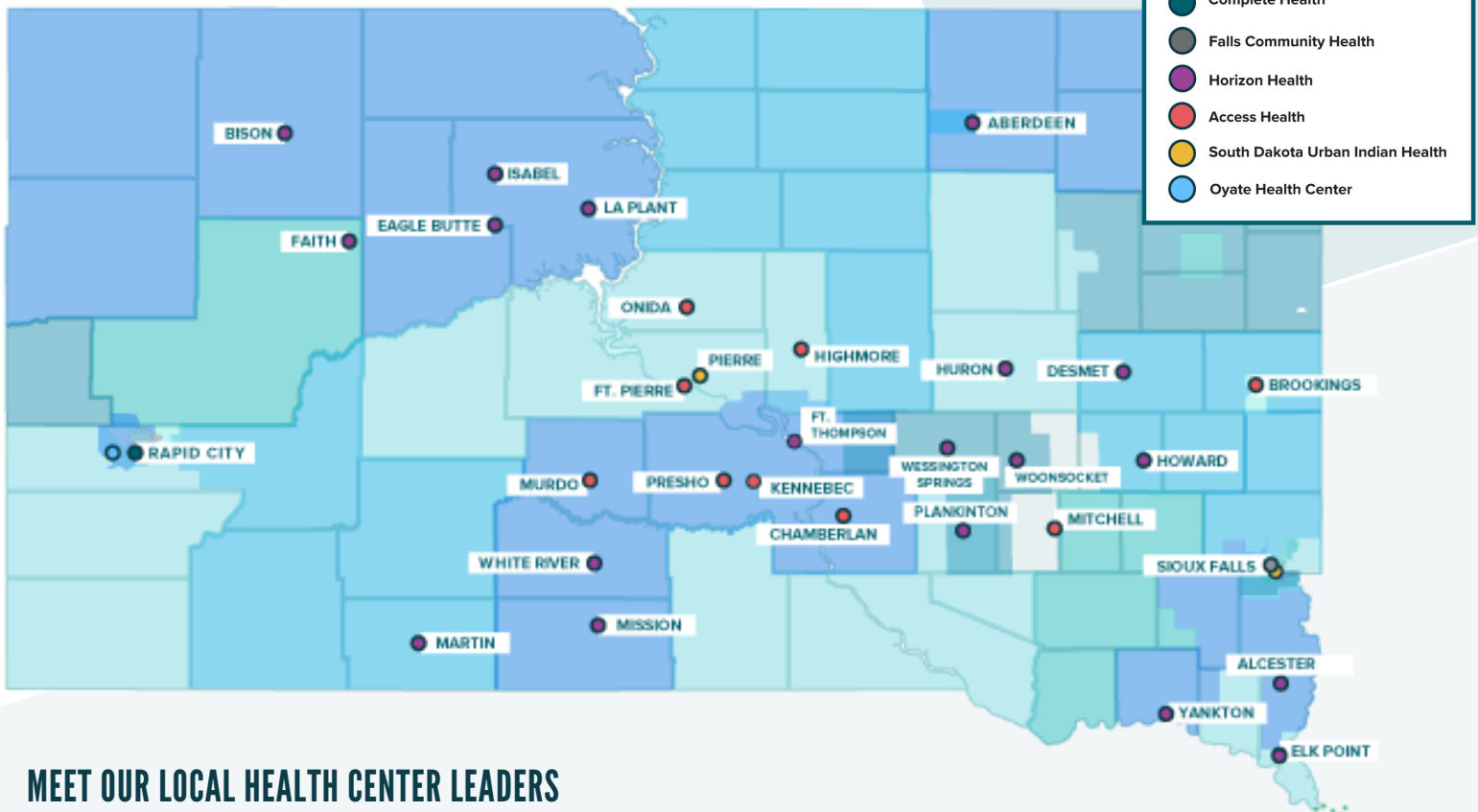

2026 LEGISLATIVE PRIORITIES



Advance Access to Care and Sustainability

Every South Dakotan should have access to timely, affordable, and preventative health care. Sustaining primary care delivery and protecting health insurance coverage improves outcomes and lowers long-term costs for everyone.

- **Sustain health center care delivery**
Ensure fair and stable Medicaid reimbursement rates for federally qualified health centers in South Dakota. The current rates cover around half the cost of a Medicaid visit according to a recent rate study conducted by the Department of Social Services. Most health centers have not had their rates reset based on their evolving care model and the total cost of providing care in 25 years.
- **Protect and optimize health insurance coverage**
Support enrollment technology and outreach initiatives that help Medicaid-eligible residents maintain continuous coverage and reduce administrative churn.
- **Protect 340B**
Ensure patients have access to affordable medications at local, hometown pharmacies.
- **Improve outcomes and reduce costs**
Prevent illness and bring down overall health care costs by investing in high-quality primary care with value-based payment, quality incentives, and interoperability.



Strengthen the Health Care Workforce

South Dakota's health centers are vital anchors for public health and economic vitality, providing access to care in some of the most remote and high-need areas while creating jobs and opportunities in 31 communities across South Dakota.

- **Expand workforce recruitment and retention tools**
Increase funding and streamline eligibility for state and federal loan repayment, recruitment assistance, and scholarship programs to attract and retain high-quality primary care health professionals.
- **Support pipeline development and team practice**
Strengthen partnerships between education programs, health centers, and state agencies to fill vacant training seats and prepare local talent for high-demand roles and ensure that health professionals can operate at the top of their training and licensure.



Promote Healthy Communities

Community health extends beyond clinic walls. Addressing social and environmental factors helps families stay healthy and strengthens South Dakota's workforce and economy.

- **Address barriers to health and wellness**
Support programs and partnerships that reduce food and housing insecurity and other nonmedical barriers, like transportation and connectivity, to improve health and prosperity for South Dakotans.
- **Invest in prevention and wellness**
Expand community-based programs that reduce chronic disease risk and support long-term wellbeing, including taxation of products linked to adverse health effects.
- **Integrate rehabilitation into care**
Promote coordination among behavioral health, corrections, and community health providers to ensure access to evidence-based rehabilitation and recovery services for justice or drug involved South Dakotans.
